**About Juneteenth:** Juneteenth (short for "June Nineteenth") marks the day when federal troops arrived in Galveston, Texas on June 19, 1865 to take control of the state, freed 250,000 enslaved African Americans and ensured that all enslaved people be freed. The troops' arrival came a full two and a half years after the signing of

the Emancipation Proclamation. Juneteenth honors the end to slavery in the United States and is considered the longest-running African American holiday. On June 17, 2021, it officially became a federal holiday.

**About FIFA World Cup 26**<sup>TM</sup>: The FIFA World Cup 26<sup>TM</sup> will be the biggest sporting event ever – three Host Countries, 16 Host Cities, 48 teams, and 104 matches uniting an entire continent to showcase a momentous new tournament format while keeping the exciting 4-team groups to ensure the ultimate football spectacle. With more countries, cities, teams, and games, FIFA World Cup 26<sup>TM</sup> will unite the entire world on the biggest stage ever and will engage millions of fans across 16 stadiums and billions worldwide. The tournament will take place in June and July 2026.

**About SeattleFWC26**: SeattleFWC26 is the local organizing committee for Seattle's participation as one of the 16 host cities selected for the FIFA World Cup  $26^{\text{TM}}$ . As a not-for-profit organization, SeattleFWC26's vision is to foster a lasting legacy for our region, guided by the spirit of soccer, innovation and inclusion. A big part of getting ready for six FIFA World Cup  $26^{\text{TM}}$  matches, traveling fans, and teams from around the world needing fields for practice and "base camps" for their World Cup travels is improving field surfaces and playing facilities statewide. With the state's economy benefiting from the 750,000 visitors expected to travel throughout Washington, investments in fields and facilities today will pay off not only during the games, but in the positive legacy they will provide to future teams, events and athletes. For these reasons and more, the Washington State Legislature stepped up in the recent session to allocate \$15 million toward initial improvements – from stadium modernizations at Lumen Field, to upgrading soccer fields at likely practice facilities around the state. Additionally, the Legislature invested \$1 million for statewide tourism opportunities.
